MEDICATION AND PRESCRIPTION REQUESTS

We would like to remind our clients to please allow us 48 hours to make medication or prescriptions available to you. We have to adhere to strict legal guidelines when dispensing medication. All medication that is dispensed from the practice must be signed off by a Veterinary Surgeon and due to being an amblulatory practice the vets spend the majority of their day out of the office attending visits. This prevents us having to disturb them by ringing for approval when they are carrying out visits.

All written prescriptions must by completed by a Veterinary surgeon. Same day requests will incur an extra charge as this puts extra pressure on the vets to complete the paperwork within their day that is already booked up.
